I. INTRODUCTION

- Pursuant to the provisions of the High-level Meeting on ECDC held in Cairo in August 1. 1986, the rules of procedure adopted at its first meeting held in Caracas in August 1987, the provisions of the Twelfth Annual Meeting of the Ministers for Foreign Affairs of the Group of 77 held in New York in September 1988, the Seventh Meeting of the Intergovernmental Follow-up and Coordination Committee on ECDC (IFCC-VII) held in Kuala Lumpur in July-August 1989, the First Annual Meeting of the Group of 77, held in New York in September 1989, the Eighth Meeting of the Intergovernmental Follow-up and Coordination Committee on ECDC (IFCC-VIII), held in Panama City in August-September 1993, the Eighteenth and Nineteenth Annual Ministerial Meetings of the Group of 77, held in New York respectively in September 1994 and September 1995, the Ninth Meeting of the Intergovernmental Follow-up and Coordination Committee on ECDC (IFCC-IX), held in Manila on 9-12 February 1996, and the Twentieth, Twenty-first, Twenty-second, and Twenty-third Annual Ministerial Meetings of the Group of 77 held in New York respectively in September 1996, September 1997, September 1998, and September 1999 the Committee of Experts of the Perez-Guerrero Trust Fund (PGTF) for ECDC/TCDC held its fifteenth meeting in New York from 25 to 27 July 2000.
- 2. The meeting was attended by four of the six members of the Committee, representing the three regions of the Group of 77. Dr. Eduardo Praselj was elected chairman of this session. The list of participants appears as annex I.
- 3. A representative of the Treasury Division of UNDP was invited by the Committee to provide information on matters related to the yield of PGTF resources and the structure of the PGTF portfolio.
- 4. The Committee adopted the following substantive agenda:
 - 1. Review to the operations of the PGTF;
 - 2. Consideration of new project proposals;
 - 3. Assessment of the implementation of approved projects;
 - 4. Other matters.
- 5. The Committee had before it the following documents:
 - 1. Twenty-eight (28) project proposals;
 - 2. Five (5) project progress, terminal and financial reports
 - 3. Note by the Office of the Chairman on the status of approved projects
 - 4. Note by UNDP on the composition of the PGTF portfolio.
 - 5. Note by UNDP on the financial status of PGTF
- 6. According to the information submitted by UNDP on the financial status of PGTF, total available funds for supporting project proposals in 2000 are approximately US\$408,000, including interest projected to be earned until 31 December 2000. Therefore, in line with guideline A(p) for utilization of PGTF the maximum support that could be given to any individual project would be US\$81,600.

II. REVIEW OF THE OPERATIONS OF THE PGTF

7. The Committee examined a number of operational issues regarding the performance of the PGTF, namely highlights of its operations, yield and expansion of its resources, guidelines, operational arrangements, and survey on the impact of PGTF.

Highlights of thirteen years of operation of PGTF (1986-1999)

- 8. In 1986, a High-level Meeting on ECDC held at Cairo defined the main features for the operationalization of PGTF, including definition of the objectives of the Fund and criteria for project eligibility, as well as operational arrangements for the submission, appraisal and approval of project proposals.
- 9. The trust fund was established with a core capital of US\$5 million. According to the guidelines for its utilization, normally only the interest accruing on the Fund could be used for project support so as to preserve intact the initial US\$5 million. The core capital plus unexpended resources in any given year constitute the interest-bearing resources (i.e., between US\$6.2 and 6.9 million from 1987 to 1999).
- 10. From 1986 to 1999, 410 project proposals were submitted to the PGTF and according to the guidelines for its utilization, the Fund has provided support to 93 projects with a total allocation of US\$6.8 million, i.e., a yearly average of 7.1 projects and US\$520,000 respectively.
- 11. In order to increase the multiplier effect of PGTF resources, the guidelines for utilization of PGTF require that project sponsors secure contributions from other sources of an amount at least equal to the contribution requested from PGTF. Contributions from other sources for the 1986-1999 period amount to US\$14.2 million, i.e., US\$2.1 for each US\$ of PGTF resources.
- 12. A breakdown of the areas that have received support from the PGTF is as follows:

Yield of PGTF resources

- 15. Following the recommendations contained in paras. 20-23 of the report of the Committee at its ninth meeting, the situation of the interest rates and yield of PGTF resources was examined by the Committee at its fifteenth meeting.
- 16. The interest-bearing resources of PGTF include the core capital plus unexpended resources and, according to the information provided by UNDP, total US\$6.8 million as of mid-July 2000. An amount of US\$2.9 million has been invested by UNDP in medium-term instruments maturing in mid-2001, and US\$2.2 million in medium-term instruments maturing in early and late 2002, while the balance has been invested in a time deposit maturing in October 2000. The average effective yield of these resources for 2000 is in the order of 5.9 percent. Effective income for 2000 is estimated at US\$399,000. A breakdown of the main features of the investments instruments is as follows:

17. Medium-term forecasts call for a stabilization or even an increase in interest rates in the near future. In order to take advantage of this situation, the Committee recommended to reinvest in two-year instruments the US\$2.9 million from instruments that will mature in mid-2001. This will provide a staggered maturity profile for instruments in which the core capital of the PGTF has been invested (40 % of the total maturing in 2002 and 60 % maturing in 2003) that would enhance the yield of its resources. With regard to the time deposit maturing in October 2000, it is recommended to reinvest its resources in short-term instruments (3-6 months) in order to take advantage of rising interest rates.

Expansion of PGTF resources

- 18. The Committee examined again practical ways of implementing its recommendations regarding the expansion of the PGTF resources as approved by the Twentieth Annual Ministerial Meeting of the Group of 77 in 1996. In this connection, the Committee recommended that the focus should be on the following actions, to be carried out by the Chairman of the Group of 77 in New York, with the support of the Chairman of the Committee of Experts of PGTF and in close coordination with the Chairmen/Coordinators of the other Chapters of the Group of 77, as agreed at the twenty-fourth meeting of the Chairmen/Coordinators of the Group of 77 held in Geneva in March 1998.
- 19. The Committee also took note of the recommendation contained in the Havana Programme of Action adopted by the South Summit regarding the expansion of the core resources of the PGTF.
 - (a) Contributions by major donor countries
- 20. Several major donor countries have been approached by the Chairman of the Group of 77 assisted by members of the Committee of Experts with a view to enlisting their support. While the initial reaction seems to be promising, a final response is still awaited. The Committee suggested that the Chairman of the Group of 77 undertake a follow-up action at an appropriate time. In this connection, the Committee recommended that contacts be renewed with these major donor countries in the light of the recommendations of the South Summit.
- 21. In addition to actions recommended in the foregoing paragraph, the Committee also recommended that:
 - (i) The Perez-Guerrero Trust Fund be included in the UN pledging conferences for operational activities to be held in November 2000. To this end, the Committee recommended that the Chairman of the Group of 77 request the assistance of UNDP.
 - (ii) Expansion of PGTF resources be taken as a priority issue by the Group of 77 and included in the substantive discussions of the "High-level intergovernmental event on financing for development" to be held in 2001 in accordance with UN General Assembly resolution 54/196.
 - (b) Contributions by member countries of the Group of 77
- 22. The Committee welcomed the contributions already made by twelve developing countries, namely Mauritius (US\$500) in 1997; Pakistan (US\$1,000), and Singapore (US\$2,000) in 1998; the Islamic Republic of Iran (US\$3,000), the Democratic People's Republic of Korea (US\$2,000), Cyprus (US\$2,000), Thailand (US\$2,000), Malaysia (US\$2,000), Algeria (US\$2,000), India (US\$2,000), and the Philippines (US\$1,500) in 1999; and China (US\$2,000)

and the Democratic People's Republic of Korea (a second contribution of US\$2,000) up to June 2000. Total contributions from these countries amount to US\$ 24,000.

- 23. The Committee noted with satisfaction that one developing country, namely the Democratic People's Republic of Korea, had made a second contribution to the PGTF and invited other countries to follow this encouraging initiative.
- 24. The Committee stressed again that what is important is to get the largest possible number of developing countries to support PGTF with contributions, and not necessarily the magnitude of individual contributions. The Committee recommended that the Chairman of the Group of 77 renew his appeal for contributions to the PGTF, since even token contributions would have a significant impact as evidence of the commitment of developing countries to South-South cooperation. To this end, the Committee recommended to maintain the notional amount of US\$2,000 as contribution to the Fund but suggested that larger contributions should be sought from member countries in a position to contribute more.
- 25. The Committee also recommended that a pledging item be included in the agenda of the Annual Ministerial Meeting of the Group in September each year, with a view to enlisting contributions from developing countries to the PGTF resources.
 - (c) Contributions by private foundations
- 26. The Committee recommended that a limited number of major potential sources of funding be approached with a view to establishing a durable relationship with these foundations in support of PGTF activities. In this connection, the Committee will assist the Chairman of the Group in preparing the necessary documentation.
 - (d) Support by UNDP
- 27. The Committee reiterated the recommendations made at its previous meeting, as follows:
 - (i) The UNDP should contribute to the above-mentioned ongoing efforts with a view to mobilizing additional resources for PGTF activities, in accordance with decisions taken by various ministerial meetings of the Group of 77.
 - (ii) The UNDP should be requested to examine the possibilities of releasing unspent resources in existing trust funds. In this connection, it recommended again that the Chairman of the Group of 77 approach the Administrator of the UNDP to this end.
 - (iii) One important element in fund raising is to increase awareness of the characteristics, past experience and potential of the PGTF. In this regard, it was felt that appropriate channels should be utilized such as press articles, and interviews in addition to the current dissemination mechanisms undertaken by the Office of the Chairman.

(iv) A better understanding of the main features of an effective fund-raising campaign is necessary so as to increase the prospects of success of this effort. In this connection, experts in this field should be approached in the near future with a view to seeking their advice and incorporate their recommendations where appropriate.

Survey of the impact of PGTF

28. On the basis of the recommendation of the Committee at its twelfth meeting in 1997, a survey on the impact and benefits of the projects funded by PGTF was initiated in 1998, with a view to supporting the promotion of the Fund. To date the Office of the Chairman has received information on 22 of the 38 PGTF-supported projects that have been completed. A summary of the results of the survey is presented in section V of this report (paras. 430 to 447).

III. CONSIDERATION OF NEW PROJECT PROPOSALS

- 29. The Committee had before it twenty-eight (28) project proposals submitted to avail of the financing of the PGTF. The list of these proposals is as follows:

- 30. The following six (6) project proposals were received after the established deadline of 30 April 2000 and therefore were not considered by the Committee at this session. They will be taken up at the next meeting of the Committee.
 - (1) Quinoa (Cchenopodium quonoa Willd) a multipurpose crop for agroindustrial uses in the Andean countries
 - (2) Analysis of financing policies for agricultural exports from Mercosur member countries
 - (3) Improving Awassi Sheep Productivity by Using Frozen Semen in Jordan and the Palestinian Authority
 - (4) Literacy and post-literacy campaign (Cuba and Haiti)

Project Proposal No. 1- Programme for regional technical cooperation in the field of integration in Mercosur member countries

31. The proposal was submitted by the member institutions of the Mercosur Economic Research Network through the Ministry of Foreign Affairs of Uruguay. Nine institutions members of this network from the four member countries of Mercosur would participate in the project.

- 32. According to the text of the proposal, the objective of the project is to define and implement a set of activities in order to create, consolidate and strengthen the articulation among the main stakeholders in the regional integration process of the Southern Cone and the regional economic researchers. The project seeks to enhance the contribution of research to the management and development of the integrated process, as well as to allow for the most efficient performance of the countries and actors involved in such process.
- 33. Total cost of the project, to be carried out over a one-year period, is estimated at US\$178,000. The contribution sought from the PGTF amounts to US\$126,000. A breakdown of the total cost is as follows:

A revised version of the proposal indicated a US\$200,000 contribution from other sources but no details were provided to the Committee.

- 34. The Committee considered that this proposal complies in general with the guidelines for utilization of PGTF, and is therefore eligible for financing. However, the contributions sought from PGTF exceeded the ceiling for 2000. In addition, in the light of guideline A(m), which requires that all project proposals submitted to PGTF should include inputs from other sources of an amount at least equal to the amount requested from PGTF, the maximum support that could be given to this project would amount to US\$52,000.
- 35. The Committee recommended that some components of this proposal avail from the financing of PGTF and that US\$40,000 be allocated to this end. This amount would be used to support travel and/or contracts components of the project. This contribution should be disbursed in two tranches, disbursement of the second tranche being subject to the timely presentation of the relevant progress and financial reports.

Project Proposal No. 2 - Price/Volume Indices, Development and Implementation in Saint Lucia

36. The proposal was submitted by the Ministry of Finance and Sustainable Development of Saint Lucia.

- 37. According to the text of the proposal, the objective of the project is to develop and implement price/volume indicators for Saint Lucia in order to provide a more reliable, comprehensive, coherent and consistent picture of its economy.
- 38. Total cost of the project to be carried out in four months is estimated at US\$54,110. The contribution sought from PGTF amounts to US\$46,675.
- 39. In the light of the information provided, the committee considered that this proposal corresponded to a national project that is not eligible for funding from PGTF. The Committee therefore recommended that this proposal should not avail from the financing of PGTF.

Project Proposal No. 3 - Measurement and comparative analysis of technology information processes in Mercosur member countries

- 40. The proposal was submitted by the Institute of Social Studies of Science and Technology at the National University of Quilmes, Argentina, through the Government of Paraguay.
- 41. According to the text of the proposal, the objectives of the project are: (a) to carry out a comparative analysis of information gathered in technology innovation surveys on efforts deployed and results achieved by Mercosur enterprises aimed at improving their technological capabilities; and (b) to prepare a common methodological proposal for measurement and analysis of technology innovation processes in Mercosur.
- 42. Total cost of the project to be implemented in eleven months is estimated at US\$226,950, contribution sought from PGTF being US\$104,950. A breakdown of the total cost is as follows:

Total contribution (IICh)

43. The Committee found that it was not possible to ascertain the cooperative component of the project since the proposal does not include written evidence of the declared interest of and explicit participation by potential beneficiaries in the activities of the project, as required by guideline A(f). The Committee therefore recommended that this proposal should not avail from the financing of PGTF.

Project Proposal No. 4 - EPPP - Electronic Prototype Production Project in Ethiopia

- 44. The proposal was submitted by the National Scientific Equipment Centre (NSEC) of the Ethiopian Science and Technology Commission. Participating countries in this project would be Ethiopia, Tanzania, and Zimbabwe.
- 45. According to the text of the proposal, the objectives of the project are: (a) to assist participating countries by providing state-of-the-art maintenance techniques through the use of printed circuits both through-hole and surface-mounted; (b) to pool expert knowledge in electronic prototype production; and (c) to develop the electronic industry in the subregion.
- 46. Total cost of the project to be carried out over a two-year period is estimated at US\$305,000, the contribution sought from PGTF being US\$105,000. A breakdown of the total costs is as follows:

47. The Committee considered that this proposal complies in general with the guidelines for utilization of PGTF. and is therefore eligible for funding. However, the contribution sought from PGTF exceeded the ceiling per project for 2000. Therefore, the Committee recommended that some components of the project be financed by the PGTF, namely "personnel", "training" and "travel". The Committee therefore recommended that US\$40,000 be allocated to this end. This contribution should be disbursed in two tranches, disbursement of the second tranche being subject to the timely presentation of the relevant progress and financial reports.

Project Proposal No. 5 - Strengthening of education and training in the field of nutrition in Honduras

- 48. The proposal was submitted by the Technical and International Cooperation Secretariat of Honduras.
- 49. According to the text of the proposal, the objective of the project is to improve the organization and functioning of programmes and projects for food and nutrition, so as to contribute to reduce malnutrition indices in the country's population.

- 50. Total cost of the project, to be carried out in one year, is estimated at US\$105,000, the totality of which is sought from the PGTF. The proposal indicates that there will be contributions in kind from Honduran institutions but no figures were provided to the Committee.
- 51. In the light of the information provided, the Committee considered that this proposal corresponded to a national project that is not eligible for funding from PGTF. The Committee therefore recommended that this proposal should not avail from the financing of PGTF.

Project Proposal No. 6 - Primary school "Druga Osnovna", Municipality Gracanica in Bosnia-Herzegovina

- 52. This proposal was submitted by the Federal Ministry of Education, Science, Culture, and Sports of Bosnia-Herzegovina.
- 53. According to the text of the proposal, the objective of the project is the reconstruction and extension of the primary school "Druga Osnovna".
- 54. Total cost of the project to be carried out in one year is estimated at US\$307,000. The contribution sought from PGTF is US\$105,000 and there would be a contribution of the Kingdom of Jordan of US\$147,000.
- 55. In the light of the information provided, the Committee considered that this proposal corresponded to a bilateral project that is not eligible for funding from PGTF as stated in guideline A(g) for utilization of PGTF. The Committee therefore recommended that this proposal should not avail from the financing of PGTF.

Project Proposal No. 7 - Building of mini sheep farms at small husbandry farms in Bosnia-Herzegovina

- 56. The proposal was submitted by the organization Pro-Best-Pro headquartered in Mostar, Bosnia-Herzegovina through the Government of the country.
- 57. According to the text of the proposal, the objective of the project is to build 150 minifarms in order to reconstruct the war-destroyed sheep-breeding capability of the country.
- 58. Total cost of the project to be carried out in twelve months is estimated at US\$21 million. There is no indication of the contribution requested from PGTF.
- 59. The Committee considered that this proposal corresponds to a national project that is not eligible for funding from PGTF. In addition, the scope and dimensions of the project exceed considerably the purview of the PGTF. The Committee therefore recommended that this project should not avail from the financing of PGTF.

Project Proposal No. 9 - Sheep-breeding resumption in Bosnia-Herzegovina

- 60. These five proposals were also submitted by enterprises and institutions from Bosnia-Herzegovina and endorsed by the Government of that country.
- 61. The Committee examined the foregoing five proposals and found that both the scope of the beneficiaries of these project proposals are of a national character and therefore are not eligible for funding from PGTF.
- 62. The Committee recommended that project proposals Nos. 8-12 should not avail from the financing of PGTF.

Project Proposal No. 13 - Multilateral Project for Strengthening Cooperation in Science and Technology in the Andean Group member countries

- 63. The proposal was submitted by the National Council of Science and Technology (CONCYTEC) from Peru. Institutions from Bolivia, Colombia and Venezuela would also be participating in the project.
- 64. According to the text of the proposal, the project aims at: (a) fostering preparation of joint research programmes and projects; (b) sponsoring fellowships in the framework of these programmes and projects; (c) promoting the establishment of cooperation networks in research and development priority areas; and (d) organizing visits aimed at identifying joint programmes and projects.
- 65. Total cost of the project, to be carried out over a two-year period, is estimated at US\$295,000, the contribution requested from PGTF being US\$115,000. A breakdown of the total costs is as follows:

- 66. The Committee considered that even though a detailed list of participating institutions is included in the project proposal, there is no written evidence of their endorsement of or declared interest in this proposal in order to be able to ascertain the cooperative component of the project, as required by guideline A(f) for utilization of PGTF.
- 67. The Committee recommended that this proposal should not avail from the financing of PGTF.

Project Proposal No. 14 - Project of regional cooperation and exchange on edible mushroom in Asia and Africa

- 68. The proposal was submitted by the Asia Pacific Edible Mushroom Training Centre (APEMTC) from the People's Republic of China and endorsed by the Ministry of Foreign Trade and Economic Cooperation of that country.
- 69. According to the text of the proposal, the objectives of the project are: (a) to disseminate farming and processing technology for edible mushrooms; (b) to increase awareness and develop local markets and consumption in beneficiary countries; and (c) to initiate bilateral and multilateral projects in this field.
- 70. Total cost of the project, to be carried out in one year, is estimated at US\$451,500. The contribution requested from PGTF amounts to US\$75,000. The Committee found inconsistencies between the summary and detailed budget figures contained in the proposal with regard to total cost of the project.
- 71. In the light of the information provided, the Committee considered that it was not possible to ascertain the cooperative element of this project as required by guideline A(f). Even though there is a list of potential beneficiary countries, there is no written indication of their endorsement of or declared interest in participating in the project.
- 72. The Committee recommended that this proposal should not avail from the financing of PGTF.

Project Proposal No. 15 - Sustainable Management of Agroforest Resources in Amazon Border Areas of Brazil, Colombia and Peru

- 73. The proposal was submitted by the National Institute for Development (INADE) from Peru. Brazil and Colombia would also be participating in the project.
- 74. According to the text of the proposal, the projects of the project are: (a) to facilitate the adoption of agreements, strategies and integrated policies for the rational and sustainable utilisation of forest resources in the Amazon area, in order to consolidate the current occupation and to guide future settlements; and (b) to standardize and describe schedules for the utilization and management of agro-forest production systems in the Amazon.

75. Total cost of the project, to be implemented in one year, is estimated at US\$250,000. The contribution requested from PGTF amounts to US\$105,000. A breakdown in the total cost is as follows:

- 76. The Committee considered that this proposal complies in general with the guidelines for utilization of PGTF. and is therefore eligible for funding. However, the contribution sought from PGTF exceeded the ceiling per project for 2000. Therefore, the Committee recommended that some components of the project be financed by the PGTF, and recommended that US\$45,000 be allocated to this end. This contribution should be disbursed in two tranches, disbursement of the second tranche being subject to the timely presentation of the relevant progress and financial reports.

Project Proposal No. 16 - Training of irrigation and drainage designers for undertaking development of water resources in developing countries in Asia

- 77. The proposal was submitted by the Irrigation Designing Institute under the Ministry of Agriculture of the Democratic People's Republic of Korea. Participating countries in the project would also be Bangladesh, Cambodia, Lao and Nepal.
- 78. According to the text of the proposal, the objectives of the project are: (a) to assist the beneficiaries in establishing the groundwork for planning in the field of irrigation and drainage for the effective use of water resources; and (b) to train experts capable of designing through practical courses of irrigation and drainage project designs.
- 79. Total cost of the project, to be implemented in one year, is estimated at US\$228,100. The contribution requested from PGTF amounts to US\$78,000. The breakdown of the total cost is as follows:

80. The Committee considered that this proposal complies in general with the guidelines for utilization of PGTF. and is therefore eligible for funding. The Committee recommended that some components of the project be financed by the PGTF and therefore recommended that US\$40,000 be allocated to this end. This contribution should be disbursed in two tranches, disbursement of the second tranche being subject to the timely presentation of the relevant progress and financial reports.

Project Proposal No. 17 - Cooperation for development and application of biological farming method among developing countries in Asia

- 81. The proposal was submitted by the Biological Branch of the Academy of Science of the People's Democratic Republic of Korea. Participating countries in the project would also be Cambodia, Lao, Nepal and Viet Nam.
- 82. According to the text of the proposal, the objective of the project is to establish the biological farming method and system for each country's situation and train technical personnel in this field on collective self-reliance principles in order to solve the food and pollution problems.
- 83. Total cost of the project, to be implemented in one year, is estimated at US\$224,500. The contribution sought from PGTF amounts to US\$78,000. A breakdown of the total cost is as follows:

84. The Committee considered that this proposal complies in general with the guidelines for utilization of PGTF. and is therefore eligible for funding. The Committee recommended that some components of the project be financed by the PGTF and therefore recommended that US\$40,000 be allocated to this end. This contribution should be disbursed in two tranches, disbursement of the second tranche being subject to the timely presentation of the relevant progress and financial reports.

Project Proposal No. 18 - Process of integration of financial systems in Mercosur member countries

- 85. The proposal was submitted by the Government of Argentina on behalf of the Mercosur member countries.
- 86. According to the text of the proposal, the objective of the project is to carry out a study on the impact of the integration of financial markets in Mercosur with a view to presenting options to the central banks of member countries for the enhancement of the instruments for controlling the system.
- 87. Total cost of the project, to be implemented in three months, is estimated at US\$78,000 the totality of which is the contribution requested from PGTF. The proposal contains an indication that the central banks of each country would make available documentation and human resources for the project, but the text gives no indication of the value of this potential contribution.
- 88. The Committee considered that this proposal does not comply with guideline A(m), which requires that all project proposals submitted to the PGTF should include inputs from other sources of an amount at least equal to the resources requested from PGTF.
- 89. The Committee therefore recommended that this proposal should not avail from the financing of PGTF.

Project proposal No. 19 - Toward Asia Pacific Renaissance: Recovery, Regional Cooperation and the Public Sector

- 90. The proposal was submitted by the Asian and Pacific Development Centre, an intergovernmental institution headquartered in Kuala Lumpur, Malaysia.
- 91. According to the text of the proposal, the objectives of the project are: (a) to share experiences of the crisis and the role of the public sector in the recovery process; (b) to discuss national public sector responses in specific areas with a view to identifying key factors which have facilitated or constrained public sector contributions to post-crisis adjustments; (c) to share information on public sector human and institutional capacities and state/civil society relations in the specific areas under discussion; and (d) to explore concrete initiatives for deeper regional cooperation.
- 92. The project activities would consist in the preparation and convening of a three-day seminar and workshops on the subject of "Toward Asia Pacific Renaissance: Recovery, Regional Cooperation and the Public Sector".
- 93. Total cost of the project, to be implemented in six months, is estimated at US\$130,100. The contribution requested from PGTF is US\$78,000. A breakdown of the total cost is as follows:

94. The Committee considered that this proposal in general complies with the guidelines for utilization of PGTF. In this connection, the Committee recommended that part of the travel component of the project be funded from PGTF and that US\$25,000 be allocated to this end, taking into account guideline A(m) for utilization of PGTF, which requires that project proposals should include inputs from other sources of an amount at least equal to the resources requested from PGTF.

Project proposal No. 20 - Transborder pilot project in Mali, Burkina Faso and Niger (AZAOUAK)

- 95. The proposal was submitted by the Secretariat of the UN Convention to Combat Desertification (UNCCD) on behalf of the Governments of Mali, Burkina Faso and Niger.
- 96. According to the text of the proposal, the immediate objectives are: (a) to improve the current agro-forest production systems through supporting socio-economic activities; (b) to make a rational use of natural resources in particular forestry and livestock in the framework of the concerted management of transborder spaces; and (c) to update the rules governing transborder migrations.
- 97. Total cost of the project, to be implemented in three years, is estimated at US\$302,400. The contribution sought from PGTF amounts to US\$50,000.
- 98. The Committee considered that this proposal complies with the guidelines for utilization of PGTF and is thus eligible for financing. In this connection, the Committee recommended that this project avail from the financing of PGTF and that US\$33,000 be allocated to this end.

Project proposal No. 21 - Transborder pilot project in Mali, Burkina Faso and Niger (les Cures salées de In-Tillit)

- 99. The proposal was submitted by the Secretariat of the UN Convention to Combat Desertification (UNCCD) on behalf of the Governments of Mali, Burkina Faso and Niger.
- 100. According to the text of the proposal, the objective of the project is to strengthen and improve management of shared natural resources with a view to combatting desertification and poverty and improving relations and exchanges among the transborder populations. In this connection, the project aims at creating mechanisms for concertation among different users of natural resources, to improve access to natural resources and support economic activities.
- 101. Total cost of the project to be carried out in three years is estimated at US\$189,100. The contribution requested from PGTF amounts to US\$50,000.
- 102. This proposal is the second submitted by the same group of countries this year, and according to guideline A(d) for utilization of PGTF, proposing organizations and institutions may submit no more than one project proposal per annum for funding from the PGTF. The Committee therefore decided not to consider this project proposal.

Project proposal No. 22 - Transborder Pilot Project in Mali, Mauritania and Senegal

103. The proposal was submitted by the Secretariat of the UN Convention to Combat Desertification (UNCCD) on behalf of the Governments of Mali, Mauritania and Senegal.

- 104. According to the text of the proposal, the objectives of the project are: (a) to establish a partnership mechanism among all existing actors for combatting desertification; (b) to support the target populations in the implementation of sustainable management of natural resources; and (c) to launch a process of self-promotion of local communities on the basis of the partnership.
- 105. Total cost of the project to be carried out in three years is estimated at US\$261,625. The contribution requested from PGTF amounts to US\$52,500. A breakdown of the total cost of the project is as follows:

106. The Committee considered that this proposal complies with the guidelines for utilization of PGTF and is thus eligible for financing. In this connection, the Committee recommended that this project avail from the financing of PGTF and that US\$33,000 be allocated to this end.

Project proposal No. 23 - Assessment and Study of the Residual Effect of Pesticides utilization on crop products and flowers in Latin America

- 107. The proposal was submitted by the National University of Colombia. Institutions from Bolivia, Brazil and Guatemala would also participate in this project.
- 108. According to the text of the proposal, the objective of the project is to assess pesticides' residues in crop products such as fruits, flowers, and vegetables and their impact on the environment.
- 109. Total estimated cost of the project, to be carried out in three years, is estimated at US\$454,085. The contribution sought from PGTF is US\$100,000. A breakdown of the total cost is as follows:

- 110. The Committee considered that this proposal complies with the guidelines for utilization of PGTF. In this connection, the Committee recommended that some components of the project, namely "personnel" and "training" be funded from PGTF, and that US\$35,000 be allocated to this end.

Project proposal No. 24 - Design of the project "Strategies for reducing drug demand in Colombia, Ecuador and Venezuela"

- 111. The proposal was submitted by the Government of Colombia. Ecuador and Venezuela would also participate in the activities of this project.
- 112. According to the text of the proposal, the objectives of the project are: (a) to improve the effectiveness of preventing drug consumption through the strengthening of a research system that would enable identification of factors related to drug consumption; (b) to develop learning programmes on integrated prevention; and (c) to develop programmes for evaluation of the process and updating the conceptual frameworks in integrated prevention.
- 113. Total cost of the project, to be implemented in four years, is estimated at US\$2,223,777. The contribution sought from PGTF is US\$1,715,546.
- 114. The Committee found that this project represents the continuation of a previous project funded by the PGTF, namely INT/98/K17 "Design of a regional project to strengthen strategies to reduce drug demand in Colombia, Ecuador and Venezuela" that has not been completed. As stated by guideline B(f) for utilization of PGTF, no follow-up project would be considered until the previous one is implemented. The Committee therefore decided not to consider this project proposal. In addition, the scope and magnitude of the project exceed significantly the purview of PGTF resources.

Project proposal No. 25 - Development of a comprehensive programme of work for the implementation of the results of the Integrated Planning Workshop in Science and Technology for the Caribbean and fostering of collaboration with the smaller countries of Latin America

- 115. The proposal was submitted by the Government of Guyana on behalf of the Caribbean Council for Science and Technology.
- 116. According to the text of the proposal, the objective of the project is to assist governments through strengthening of their national science councils in the design and implementation of integrated and coordinated science and technology policies and programmes for development.
- 117. Total cost of the project, to be implemented in one year, is estimated at US\$311,000. The contribution sought from PGTF is US\$66,000. A breakdown of the total cost is as follows:

118. The Committee found that this project represents the continuation of a previous project funded by the PGTF, namely INT/97/K03 - "Integrated planning and new technologies for sustainable development" that has not been completed. As stated by guideline B(f) for utilization of PGTF, no follow-up project would be considered until the previous one is implemented. The Committee therefore decided not to consider this project proposal.

Project proposal No. 26 - Program of Prevention in Peru and Control in Ecuador and Colombia against the Guatemalan moth

- 119. The proposal was submitted by the Government of Peru. Colombia and Ecuador would also participate in the activities of the project.
- 120. According to the text of the proposal, the objectives of the project are: (a) to achieve that Peru maintains its condition of Guatemalan moth-free country; and (b) to avoid spreading this pest currently present in Ecuador and Colombia to other pest-free areas through the strengthening of quarantine measures and integrated management of the pest.

121. Total cost of the project, to be carried out in one year, is estimated at US\$113,620. The contribution requested from PGTF is US\$78,000. A breakdown of the total cost is as follows:

122. In the light of the information provided, the Committee considered that this proposal in general complies with the guidelines for utilization of PGTF. However, as stated in guideline A(m) all projects proposals submitted to PGTF should include inputs from other sources of an amount at least equal to the resources requested from PGTF. The Committee therefore decided to limit support to this project to the amount of "other sources" contribution and in this connection recommended that US\$30,000 be allocated to this end.

Project proposal No. 27 - Support for development of transboundary communities' activities in the Kalahari-Namib region (Namibia, Botswana, South Africa)

- 123. The proposal was submitted by the Secretariat of the UN Convention to Combat Desertification (UNCCD) on behalf of the Governments of Namibia, Botswana and South Africa.
- 124. According to the text of the proposal, the objectives of the project are: (a) to achieve sustainable utilization of natural resources in the Kalahari-Namib region; (b) to stem human induced land degradation and desertification; and (c) to improve the welfare of people in the affected areas and thus contribute to breaking the vicious circle of poverty.
- 125. Total estimated of the project, to be implemented over a five-year period, is estimated at US\$250,000. The contribution requested from PGTF is US\$60,000.
- 126. The Committee considered that this proposal in general complies with the guidelines for utilization of PGTF. However, the documentation made available to the Committee does not identify clearly the sources of other contributions (to be mobilized by SADC-ELMS), as required by guideline A(m) for utilization of PGTF. The Committee therefore recommended that this project avail of the financing of PGTF and that US\$35,000 be allocated to this end with the proviso that the other contribution should be secured prior to the signature of the project document.

Project proposal No. 28 - Strengthening the livelihood of women potters associations, in order to fight against pressure on natural resources and rural poverty (Burkina Faso, Ghana, Togo)

- 127. The proposal was submitted by the Secretariat of the UN Convention to Combat Desertification (UNCCD) on behalf of the Governments of Burkina Faso, Ghana and Togo.
- 128. According to the text of the proposal, the objective of the project is to support potters associations in the participating countries to strengthen their production activities and consequently improve their livelihoods.
- 129. Total cost of the project, to be carried out over a two-year period, is estimated at US\$30,300. The contribution requested from PGTF is US\$20,000.
- 130. In the light of the information provided, the Committee considered that this proposal in general complies with the guidelines for utilization of PGTF. However, as stated in guideline A(m) all projects proposals submitted to PGTF should include inputs from other sources of an amount at least equal to the resources requested from PGTF. The Committee therefore decided to limit support to this project to the amount of "other sources" contribution and in this connection recommended that US\$10,000 be allocated to this end.

Summary of project proposals recommended for adoption

131. In summary, the Committee recommended that the following twelve (12) new project proposals plus a budget increase for an existing project avail from the financing of PGTF and resources allocated to this end amount to US\$406,000. A breakdown of this total is as follows:

178. According to the information provided by UNDP, total available resources for funding new project proposals in 2000 amount to approximately US\$408,000. This amount includes the interest expected to be earned from 1 January to 31 December 2000. A detailed breakdown of the financial status of PGTF is provided in Annex II.

IV. ASSESSMENT OF THE IMPLEMENTATION OF APPROVED PROJECTS

179. The Committee examined the status of implementation of the projects adopted by IFCC-VI held in Havana in September 1987, by the Twelfth Annual Meeting of the Ministers for Foreign Affairs of the Group of 77 held in New York in September 1988, by IFCC-VII held in Kuala Lumpur in July-August 1989, by the Thirteenth, Fourteenth, Fifteenth and Sixteenth Annual Meetings of Ministers for Foreign Affairs of the Group of 77 held respectively in New York in September 1989, October 1990, September 1991 and October 1992, by IFCC-VII held in Panama City in August-September 1993 and by the Eighteenth, Nineteenth, Twentieth, Twenty-First, Twenty-second and Twenty-third Annual Meetings of Ministers for Foreign Affairs, held in New York respectively in September 1994, September 1995, September 1996, September 1997, September 1998, and September 1999.

On 8 March 1994, the Chairman of the Group of 77 requested UNDP to disburse, to the Office of the Chairman, the amount of US\$20,480 to finance the participation of six experts attending the Special Meeting of PGTF on 4-8 April 1994. Actual expenses for six members who attended the Ninth Meeting of the Committee of Experts of PGTF in April 1994 were US\$20,032.
- 225. From 1995 to 1997 the field offices of UNDP disbursed directly the funds needed to finance the participation of experts for the tenth, eleventh, and twelfth meeting of the Committee. According to the information provided by UNDP, total funds disbursements for this period reported from the relevant UNDP field offices amount to US\$49,921.
- 226. The Eleventh Meeting of the Committee of Experts took note that project INT/90/K08 aimed at providing support to the Committee of Experts had been extended for the year 1996. It further recommended that since around half of the allocated resources remained unspent, the project be extended for another five years. This recommendation was endorsed by the Twentieth Annual Ministerial Meeting of the Group of 77 held in New York on 27 September 1996.
- 227. The report of the Twelfth Meeting of the Committee of Experts of PGTF held on 6-8 August 1997 stated in paragraph 154 of its report that "in the light of the results of the past two years in terms of expeditiousness and cost, the Committee strongly recommended that the Office of the Chairman should resume implementation of this project as in previous years, in lieu of the country offices of UNDP."

The Office of the Chairman is planning to re-issue and translate the guidelines for utilization of PGTF in all the official languages of the Group of 77 on the occasion of the forthcoming ministerial meeting of the Group of 77 in September 1998. The cost of printing and translating the brochure will be charged to this project which contains a budget provision for such expenditure.

recommended that the Office of the Chairman request the subcontractor to provide not later than 31 December 1998 information on steps the subcontractor intends to take with a view to early launching of the project activities for consideration and appropriate recommendation by the Committee at its next meeting.

- 387. The Seventh Meeting of the Committee of Experts of PGTF (New York, 29-30 June 1992), recommended that an extension be given to ECRC to deliver the reports by 31 December 1992. The Chairman of the Group of 77 communicated this decision to the Permanent Representative of Saint Lucia to the United Nations in a letter dated 26 October 1992. This was done by the Chairman of the Group of 77 in a letter addressed to the Permanent Representative of Saint Lucia to the United Nations dated 25 February 1994.

- 389. Neither the video report nor the financial statement of expenditure have been submitted by ECRC.
- 390. By letters dated 29 April 1994 and 13 January 1995, the Chairman of the Group of 77 requested the Permanent Representative of Saint Lucia to the United Nations to submit the outstanding reports for the project. Despite these letters and follow-up telephone calls both by the Office of the Chairman and UNDP, the audio and video reports and the financial statement of expenditure have not been submitted by the ECRC.
- 391. Consequently, the appropriate steps will have to be taken to recover the funds disbursed as per the recommendation of the PGTF and the decision of the Eighteenth Ministerial Meeting of the Group of 77.
- 392. By letter dated 13 October 1995, the Chairman of the Group of 77 informed the Permanent Representative of Saint Lucia to the United Nations that the project was placed under query and requested that the necessary arrangements be made to reimburse the amount of US\$50,000 to PGTF.
- 393. By letter dated 11 March 1996, the Prime Minister of Saint Lucia, West Indies, informed UNDP that the Government of Saint Lucia will refund the monies paid for the execution of the above project.
- 394. UNDP has made available to the Office of the Chairman copies of correspondence exchanged between UNDP and the Government of Saint Lucia which state that the full amount allocated from PGTF to this project has been refunded.

- 407. By letter dated 29 April 1994, the Chairman of the Group of 77 requested the Secretariat of SADC to expedite urgently the submission of the draft Sub-contract Agreement.
- 408. The draft Sub-contract Agreement was submitted to the Office of the Chairman with its attachment letter dated 25 May 1994.
- 409. By letter dated 2 November 1994, the Chairman of the Group of 77 sent a revised original of the Sub-contract Agreement to the Permanent Mission of Botswana to the United Nations for signature and transmission to SADC for appropriate action.
- 410. The Sub-contract Agreement was not returned duly signed to the Office of the Chairman.
- 411. Given that the project document was signed in August 1993 and it was not possible to sign the sub-contract agreement and start the implementation of the project, the Committee of Experts was concerned on whether this project could be implemented at all.
- 412. In this regard, the Eleventh Meeting of the Committee of Experts recommended that a final notice be sent by the Office of the Chairman to the sub-contractor indicating that if the project implementation had not started by 31 December 1996, the allocated funds should be reverted to PGTF as required by guideline F(c) for utilization of PGTF.
- 413. In light of this, the Chairman of the Group of 77 sent a letter to the sub-contractor on 5 September 1996 urging it to start the implementation of the project by 31 December 1996. No information was ever received by the Office of the Chairman from either the sub-contractor or UNDP regarding the status of implementation of this project.

Date of signature of relevant documents: The project document was signed by the G-77 and UNDP on 26 September and 27 September 1994 respectively. A subcontract agreement between the Government of Panama and the "Instituto Geografico Nacional Tommy Guardia" was signed in November 1994.

- 416. Disbursement of US\$38,500 was made by the UNDP to the subcontractor on 29 December 1994. The disbursement was confirmed by the UNDP Resident Representative on 24 March 1995 in response to a query from the Special Unit for TCDC of UNDP.
- 417. On 8 May 1996, the Chairman of the Group of 77 requested the Permanent Representative of Panama to the United Nations to submit the outstanding final report and financial statement of expenditure.
- 418. On 8 August 1996, the Special Unit for TCDC requested the Resident Representative of UNDP in Panama to contact the sub-contracting agency with a view to expediting the submission of the outstanding reports.
- 419. On 12 May 1997 the Special Unit for TCDC requested the UNDP Resident Representative in Panama to provide information on the progress of the project and to accordingly report to the Unit.
- 420. On 23 May 1997, the Chairman of the Group of 77 made an urgent appeal through the Permanent Representative of Panama to the United Nations for the submission of the outstanding reports.
- 421. In a fax dated 26 May 1997, the UNDP Resident Representative in Panama informed the Director of the Special Unit for TCDC that the project had not been implemented by the subcontracting agency and that the latter had given to understand that the Ministry of Foreign Affairs of Panama had advised the Special Unit for TCDC accordingly.
- 422. In a letter addressed to the Resident Representative of UNDP in Panama dated 6 June 1997, the Director of the Special Unit for TCDC of UNDP expressed surprise to learn of this development. The communication stated that the Special Unit for TCDC had not received the letter from the Ministry of Foreign Affairs of Panama on this matter and requested clarification as to whether the project had been postponed or that the resources already disbursed would be refunded to the PGTF.
- 423. On 26 June 1997, the Officer-in-Charge of UNDP in Panama forwarded to the Special

Unit for TCDC copies of two communications addressed to the Ministry of Foreign Affairs of Panama which stated the reasons for the non-implementation of the project. The Office-in-Charge of UNDP stated that the Government of Panama had agreed to refund to PGTF the resources already disbursed.

- 424. The Twelfth Meeting of the Committee of Experts of PGTF held on 6-8 August 1997 recommended that "UNDP should take the necessary steps so as to ensure that the funds disbursed be reimbursed to the PGTF not later than 31 December 1997."
- 425. By letter dated 5 December 1997 addressed to the Director of the Special Unit for TCDC, the Chairman of the Group of 77 requested UNDP to follow up the matter with the Government of Panama with a view to securing refund of the PGTF resources already disbursed and to keep the Office of the Chairman fully informed of developments.
- 426. On 12 January 1998, the Officer-in-Charge of the Special Unit for TCDC informed the Chairman of the Group of 77 that the matter had been brought to the attention of the Resident Representative of UNDP in Panama and that the Office of the Chairman would be kept posted of developments.
- 427. Since no further information has been received by the Office of the Chairman on this matter, the Committee recommended that this project be placed under query and recommended that, in addition to the action taken by the UNDP, the Office of the Chairman request the Permanent Representative of Panama to the United Nations to take appropriate action with a view to refunding the disbursed funds.
- 428. On 19 January 1999, the Resident Representative of UNDP in Panama addressed a letter to the Minister for Foreign Affairs of Panama requesting the reimbursement of the disbursed funds. On 8 June 1999 the Chairman of the Group of 77 addressed a similar request to the Permanent Representative of Panama to the United Nations. No replies have been received to these communications.

V. OTHER MATTERS

429. The Committee agreed that the deadline for the submission of project proposals by Member States for consideration at its next regular session will be 30 April 2000, in accordance with the revised guidelines for utilization of PGTF. It is understood that the date of submission of proposals is the date when they are officially received by the Office of the Chairman. At this session, the Committee will also consider the project proposals referred to in para. 30 of this report.

Survey of the impact of PGTF

430. The Committee recommended at its twelfth meeting to carry out a survey of the impact

and benefits of the projects funded by the PGTF with a view to supporting the promotion of the Fund. So far, the Office of the Chairman has received information on 22 of the 38 PGTF supported projects that have been completed. Further reports are expected so as to be able to prepare a comprehensive assessment of the impact of PGTF since its operationalization in 1986. A brief summary for each completed project is provided below:

- (3) Technical Co-operation among SELA member States in artificial insemination and embryo transplants

Date of implementation: 1989-1993

Impact: The project created a network of institutions that introduced or improved artificial insemination and embryo transplant procedures. Outstanding results have been achieved in Cuba, Chile, Uruguay and Brazil. Development of these bio-technologies in the region is significant and their use is an everyday occurrence today.

- (4) Export promotion and cooperation in favor of less developed countries within the Latin American Integration Association (ALADI)

(10) Regional symposium on the economic and social impact of money derived from illicit drug trafficking in the development of Latin America and the Caribbean

Impact: Publication of a book containing the conclusions of the symposium which aimed mainly at an integrated approach to the problem including both producing and consumer

Date of implementation: 1996-1997

Impact: The study provided a clear and objective understanding of the role that FDI is playing in the integration process of the region. Extracts from the study were reproduced as discussion papers in technical and policy level meetings in the Mercosur. However, its

actual impact on FDI policies needs further clarification.
